

**Strack & Van Til Sizzling Summer Sweepstakes
OFFICIAL RULES:**

ENTRY METHOD:

There are two ways to enter.

- (1) Purchase Method. You must have an active Rewards Made Easy Account to enter this Sweepstakes. You are entered by using your Rewards account while shopping at Strack & Van Til during the Sweepstakes period. You can setup your account by downloading the Strack & Van Til app or signing up at <https://strackandvantil.com/rewards>.
- (2) Non-purchase Method. To enter without making a purchase, print your full name, e-mail address, street address, city, state, zip code, telephone number and provide your signature (your signature certifies that you are 18 years of age or older and have complied with all of the Official Rules of this Sweepstakes) on a 3" x 5" card and mail to: Strack & Van Til Sizzling Summer Sweepstakes c/o Strack & Van Til, Marketing Department, 2244 45th Street, Highland, IN 46322 to be entered in the Sweepstakes. There is no limit to the amount of entries, regardless of entry method.

SWEEPSTAKES PERIOD: The Strack & Van Til Sizzling Summer Sweepstakes (the "Sweepstakes" or "Promotion") starts on June 3, 2026 at 12:00:00 AM Eastern Time ("ET") and ends on June 30, 2026 at 11:59:59 PM ET (the "Promotion Period"). Sponsor's computer runs the official clock for the Sweepstakes and will solely determine the time by which an entry is received.

ELIGIBILITY: The Sweepstakes is open only to legal residents of the states of Indiana, Illinois, or Michigan who are eighteen (18) years of age or older at the time of entry. Employees and non-employee workers of Strack & Van Til (the "Sponsor"), Hy-Vee, Inc., and their respective, parents,

subsidiaries, members, agents, representatives, officers, directors, and shareholders (collectively "Released Entities"), and the immediate families (spouse and parents, children and siblings, and their respective spouses regardless of where they live) and individuals living in the same households, whether related or not, of the above, are not eligible to enter or win a prize. Odds of winning depend on the number of eligible entries received with the combination of electronic and mail in entries. Mail in entries will be included in the weekly drawing in which the entry was received by mail. Weekly drawings will be conducted within 48 hours of the completion of that ad week. Winners need not be present to win. Winners will be notified through the contact information provided in the Rewards Made Easy Account setup or mail in postcard.

Winner may waive his or her right to receive the prize. Prize is non-assignable and nontransferable. No substitutions allowed by winner. Prize is subject to availability, and Sponsor reserves the right to substitute prize of equal or greater value. Winner is solely responsible for reporting and payment of any taxes on prize.
